Police Report

Recent crimes/issues in the area:

Assessment period - 20/03/2024 - 15/05/2024

There were **27** calls to the Muirhead, Birkhill, Fowlis and Liff area during this assessment period.

9 crimes were recorded. A break down as follows: -

Group 1 - Crimes of violence - 0

Group 2 – Sexual crime. 0

Group 3 – Crimes of dishonesty (includes shoplifting & fraud) - 5 crimes recorded.

Group 4 - Crimes involving property damage - 0

Group 5 & 6 – Miscellaneous/ other crimes including threatening & abusive behaviour, offences against emergency workers and retail workers - 2 crimes recorded.

Group 7 – Motoring offences – 2 crimes recorded.

Emerging issues locally:

Several residents have contacted Local Community Police Officers regard vehicles allegedly speeding through posted 20mph limits.

Those residents who have contacted Police have been spoken too and advised regards the rules relating to this scheme introduced by Angus Council.

We will continue to carry out high visibility patrols and checks as and when time allows.

Other topics of note or messages:

Calls to the Police and recorded crime are both down on the last assessment period. Calls to the Police during this assessment period are the lowest they have been since 2023.

Can we please remind all residents about the importance of home and vehicle security, ensuring vehicles and doors are locked, no valuables are left in vehicles overnight and that all residents review their own home security, for example – lighting, CCTV, Ring doorbell camera's, lines of sight to your own and neighbours' properties etc.

Resilience Event	20/03/2024	MBLCC plan to host a public resilience event with various emergency responders such as Scottish Power, Scottish Flood Forum, Fire brigade, Police. Explains to households what they might want to put into place themselves (Household resilience); Possibly do DeFib awareness talk; Perhaps some CPR training. Jennifer Anderson from the Angus Council Resilience team suggested a Saturday morning in March with some refreshments and some fun things for children to do. Once there is an agreed date with a quorum of attendees this information will be shared as widely as possible and start asking what Volunteers could bring to a allow us to create a Skills/Assets Register. - At this event we may look for Volunteers to work with the CC on a Community Resilience Team - It would be useful if the community were able to point out areas at risk on a map at the event (e.g. which public roads were flooded (and where) along with private properties that were also flooded. This was replaced by the Flood Mobile. This event was organised in collaboration with Angus Council and was noted as being very well attended today.
		Based on the discussions that were had one of the next steps is to work with the Scottish Flood Forum on our flood map. They will help us to translate our sketch information into a digital map that we can share with SEPA, and it may lead to the identification of other actions that can be taken to alleviate local issues. RJ to action sketch flood map and pass to Scottish Flood Forum.
		Much was said of the impact of farming in the area. RJ will discuss with some local farmers to understand what they can and cannot do, and the regulations that they work under (e.g. SEPA). RJ will report back at the next meeting.
	15/05/2024	At the last meeting we took notes of areas that were hit during recent spates of flooding. We further followed this up with a Facebook post seeking more information from the Community. This was met with an enthusiastic response and all the data was recorded on a map which has been sent to the Scottish Flood Forum. This is an organisation that supports communities at risk from flooding. They have advised that they will help us to digitise this information and we hope to be able to use this to inform future resilience plans.
		In addition to this, there has been much discussion in many of the meetings regarding the management of farm land in our area, the management of waterways, the roles of SEPA and famers, and whether this could have had a detrimental effect and exacerbate the flooding that we saw in 2023. Rose has

			This planning application was approved and news of this was conveyed in the Courier on the 12th of March 2024. It was brought to the attention of the Muirhead, Birkhill, and Liff Community Council on the 15th of March 2024. The community council members were surprised at this because we were unaware of the planning application despite receiving the weekly planning lists. When we receive these we search through for the ones that are noted as assigned to our Community Council in the information. We did not find this application.
			We were aware of this development as the applicants came to one of our meetings to discuss this with us in 2023, and they spoke to us as part of their initial consultation prior to making a full application. We had members of the public in attendance as well at the time, and there were concerns raised at that point about the access routes and impact of traffic on Gourdie Brae and towards Liff.
			We were unsure how we could have missed the full application being submitted as we would have wished to comment on any proposals that could cause implications for traffic access and egress and general road safety, and we would have reflected the concerns raised in the consultation had there been no changes to the initial proposals that were presented. Upon further inspection, we can see that the application was wrongly assigned to Monifieth Community Council. As a result, we did not find the application in our weekly searches.
			We were very concerned that due legal process has not been followed; the application was not validated correctly with the basic details, and as a statutory consultee we were not afforded the opportunity to comment on this application due to, we assume, an administration error on behalf of Angus Council. The application being wrongly assigned to Monifieth

			made it unsearchable for us or anyone living in our area who may have had an interest in commenting.
			In light of this, we have written to the Council and asked how this could have happened and why no one in the planning committee checked that it had been correctly assigned, and whether there is any recourse that would allow the population of the Muirhead, Birkhill, and Liff Community Council to review a major proposal that significantly affects them. The initial response that we received was unacceptable as this basically blamed the Community Council for not checking the addressing on the several pages of documents that are issued on the list each week. We wholly rejected this position and submitted a formal complaint detailing our concerns and asking for information on how this could have happened and be prevented int the future again. Cllr Whiteside and Cllr Melville also raised their concerns that this had happened. As a member of the Planning Committee they had read the associated reports during the meeting and assumed that our lack of response meant no concerns had been raised. We await a formal response to our complaint. In the meantime, a statement has been posted on the Facebook pages.
		15/05/2024	We received a response to our formal complaint today (which should have received over two weeks ago) after formally raising the issue again last week where we asked for an urgent response as they are not following the Public Bodies Complaints Handling Procedure. They have changed their process to help ensure this doesn't happen again by adding in a senior officer review to check the correct CC is mentioned in planning reviews.
