As the current Community Council reaches the end of its term I would like to thank

- the Community Council members and in particular the office bearers, for their hard work, on behalf of the communities in this part of Angus. It was good to have representation on the council from across our area.
- the Angus Councillors, Fotheringham and Hands, who have regularly attended our meetings and given us much appreciated support
- the public who have shown an interest and, in particular, those who regularly attended our meetings

The Community Council has achieved a considerable amount during its term of 4 years, too much to list in this report, and having our own website and Facebook page has allowed us reach out to the residents to let them know what their Community Council has been doing on their behalf. The noticeboards around our area also allow word of our activities to be spread but keeping residents up to date, and in some cases having space for the information, can be a challenge.

Without the Community Council it is unlikely that

- the park at the Millennium Hall would be draining properly
- aspects of the roads and signage would as good as they are and
- there would be the same level of bus service.

As Angus Council still focuses most of its resources on the Burghs, that is mainly to the east of the A90, it is important to have an active Community Council to remind them of our existence.
