**Police Report** – Police report circulated – 67 calls & 8 crimes reported in our area, scam campaign information to be put on Facebook. Our Community Police Officer PC Beattie has now retired – we thanked her for all her work in our area. We do not have a named person for our area to replace her, but we do have Community Policing contacts if required.

#### Recycling centre update

Agreement has now been reached between Angus and Dundee councils - Angus Council residents in the Monifieth and Sidlaw areas are now able to make full use of recycling centres within Dundee.

# **Traffic in Muirhead and School parking**

Parking at Birkhill Primary. It has been spoken about at Angus Council traffic coordinators meeting and letters have been written to parents but it is still an issue and getting worse. Local residents to log issues and take photos which will be passed to both Angus Council and Community Police.

Parking on Coupar Angus road at chemist and area round the junction / shop. Issue at chemist with cars leaving no pavement space forcing walkers onto the road and dangerous parking in other areas. Can we get markings put on pavement at chemist?

Parking at Liff Primary. This has been an ongoing discussion with the parent council and is not improving. To be raised with the Community policing again.

Actions: Cllr Whiteside to pass any issues & photos onto Angus Council

Cllr Whiteside to contact Angus Council about road markings at the chemist

AF to contact Community Policing regarding ongoing issues at both Birkhill & Liff schools and pass any photos Speeding in Muirhead. Discussion over various options for slowing traffic speed on the 2 roads at the west end of Muirhead. Local residents to be asked for their comments to be passed to Angus Council.

Actions: Cllr Whiteside to ask Angus Council about options and a 20mph limit at the end of Muirhead

KJ to ask Angus Council for the data from the VAS

Local resident to encourage residents to send comments to Angus Council and MBLCC to pass on

#### **Henderson Park goalposts**
